Publishing Agreement

This PUBLISHING AGREEMENT is dated, between ...<author's name>..... and the **University of Pennsylvania Press (the Publisher)** is pleased to have the opportunity to publish your contribution, entitled in the journal entitled **Observational Studies** (the Journal). This form, when properly completed, will provide the necessary formal agreement. You, as author of the contribution, and the University of Pennsylvania Press agree as follows:

The Publisher undertakes to publish your contribution in the Journal named above. The Publisher will register the Work with the U.S. Copyright Office in the Author's name or in the name of the Publisher. Author agrees to provide Publisher with the information necessary to register the Work and to certify the application. The Work will be distributed under a Creative Commons Attribution Non-Commercial 4.0 International (CC BY-NC 4.0) license. This license lets others re-use the article non-commercially; new works must also acknowledge the Author as the originator and be non-commercial.

The Author grants to the Publisher a non-exclusive license to

- use, publish, edit, reproduce, distribute, publicly perform, publicly display, and prepare derivative works based upon the Work, in whole or in part, for any purpose associated with this Agreement;
- an exclusive license to use, publish, edit, reproduce, distribute, publicly perform, publicly display, and prepare derivative works based upon the Work, in whole or in part, in the Licensed Formats for Commercial purposes, and to exercise the Licensed Subsidiary Rights in the Work for Commercial purposes ("Commercial" means primarily intended for or directed towards commercial advantage or monetary compensation.)
- the right to use Author's name, likeness, and biographical information in association with Publisher's activities undertaken in connection with this Agreement, including without limitation in the promotion, advertising, sales, and licensing of the Work; and the right to make the Work available through appropriate open access formats and forums, including applying a Creative Commons license to the Work.
- These licenses and authorizations shall be in perpetuity (subject to termination and reversion), sublicensable, worldwide, and in all media now known or later developed. Author reserves all rights not granted to Publisher in this Agreement.

1. You represent and warrant that your contribution is original and that you are the sole author of it and have full power to make this agreement; that your contribution has not been previously published, in whole or in part, and that there are no agreements to publish it now outstanding; that you have used reasonable care to ensure that all statements in your contribution purporting to be factual are true; that your contribution is not defamatory, obscene, or otherwise unlawful; and that it does not violate any right of privacy or statutory copyright or other personal or property rights.
2. You agree to obtain promptly, at your expense, all permissions necessary for reprinting copyrighted material in your contribution—in print and digital editions—including poetry, song lyrics, lengthy prose extracts, letters, and other textual material under copyright, and for reproducing photographs, charts, drawings, diagrams, or other illustrative matter under copyright, and to transmit such permissions letters and credit lines to the Editor with the final copies of the manuscript.
3. You will be given the opportunity to review the manuscript of your contribution after editing unless you agree otherwise. If you fail to return the edited manuscript to the editorial office with your comments within 15 days of its receipt, the Editors and **Observational Studies** may assume that you consent to all editorial changes. You agree to read, correct, and promptly return to the editorial office all proofs of your contribution sent to you at the discretion of the Editors. In the event that you fail to return proofs by the deadline set by the Editors, **Observational Studies** shall be free to proceed with manufacture and publication of your contribution without your corrected proofs. You further agree that the Editors may, at their discretion, disallow any or all of your alterations in proofs that are not solely corrections of errors made by **Observational Studies** or the compositor.
4. You understand and agree that all details as to the publishing and licensing of your contribution shall be under the sole control of the **University of Pennsylvania Press** and its agents.
5. Upon publication of your contribution in the Journal, **Observational Studies** grants you an irrevocable, nonexclusive, royalty-free license to use your contribution in any book volume consisting wholly of your own work, provided that each such use shall carry the copyright notice specified in **Observational Studies**.
6. You agree that you will receive no royalty under this Agreement.
